Public Announcements –

"Let's Talk Lead" - Lead Safe Workshop for Cayuga County Rental Property Managers & Landlords

The Cayuga County Health Department is hosting a workshop on Wednesday, February 28, 2024, for rental property owners/managers and landlords to discuss the hazards of childhood lead exposure and how to maintain lead-safe properties. Members of the Cayuga County Childhood Lead Poisoning Prevention team will be at Auburn Housing Authority, 7 Merriman Street, Auburn from 5:30 to 7:00 p.m. to answer questions and advise what to expect if lead is found after they conduct a home inspection.

For those not aware, recent amendments to New York State Public Health Law Section 1377 established a local rental registry which will require inspections to identify any leads hazards that might be present in

rental units. Copies of the new law will be provided at this workshop.

All residential rental property owners/managers and landlords with property located in Cayuga County are welcome. Registration is required and can be accomplished by calling the Cayuga County Health Department at (315) 253-1560 on or before February 27, 2024.

Participants of the workshop will have the opportunity to enroll for FREE in Renovation, Repair and Painting (RRP) training on April 19, 2024, to become an Environmental Protection Agency (EPA) Certified Lead Renovator*. The RRP training will be provided at no-cost to ensure property owners/managers and landlords are utilizing best practices to remediate and address lead hazards and create lead-safe environments. Upon successful completion of the RRP initial course participants are EPA certified renovators. This certification is good for 5 years. The Cayuga County Childhood Lead Poisoning Prevention Program also provides supplies to support and promote lead-safe work practices!

*Federal law requires workers performing renovation, repair and painting projects that disturb lead-based paint in homes, childcare facilities, and schools built before 1978 to be certified and follow specific work practices to prevent lead contamination. This includes residential rental property owners/managers and landlords. Failure to comply with EPA's RRP program requirements could result in penalties of up to \$37,500 per day per violation.

COUNCIL RESOLUTION #31 OF 2024

REQUESTING THE GOVERNOR AND STATE LEGISLATURE TO FULLY FUND MEDICAID REIMBURSEMENT IN THE GOVERNOR'S 2024-2025 NYS BUDGET

WHEREAS, Medicaid pays 30% less than the actual cost of healthcare for low-income seniors, children from low-income families, and people with disabilities in New York State; and

WHEREAS, chronic underfunding of Medicaid has created a crisis that is pushing New York's healthcare system to a fiscal breaking point and severely threatening care for our most vulnerable New Yorkers; and

WHEREAS, more than 7 million New Yorkers suffer when Medicaid is not fully reimbursed, facing difficulty accessing health care and mental health services, longer wait times in emergency rooms, a crisis in emergency ambulance sustainability, and perpetuating dangerous staffing shortages for our hospitals, nursing homes and ambulance providers statewide; and

WHEREAS, Medicaid underpayments are already severely harming low-income New Yorkers, especially in our Black and Latino communities, leading to delays in life-saving care, worse health outcomes, and shorter life expectancies; and

WHEREAS, when Medicaid is not properly and fully reimbursed the men and women on the front lines of healthcare such as our nurses, Emergency Medical Technicians, Paramedics, and social workers just to name a few are all negatively impacted; and

WHEREAS, If New York increases Medicaid reimbursements, the federal government will pay for half of the cost, reducing the cost to New York taxpayers by 50%. Fixing Medicaid underpayments will ensure that our hospitals, nursing homes, and ambulance services can hire the staff they need, and our seniors, children, and mothers and babies will receive the care they deserve.

NOW, THEREFORE BE IT RESOLVED, that Mayor Giannettino and members of the City Council call upon the Governor and members of the New York State Legislature, as New York State budget discussions proceed, to make the necessary budget decisions to fully fund Medicaid reimbursements including \$6 billion for hospitals, \$1.6 billion for nursing homes, and an adjustment to ambulance service reimbursement rates that fully covers the actual cost of care; and

BE IT FURTHER RESOLVED, that the City Clerk is directed to send a certified copy of this resolution to the Governor and our State elected representatives.

SUBJECT: SEQRA Resolution # 2 of 2024 Determining Type II Actions Under SEQRA

for Lake Avenue Bridge Rehabilitation Project

BACKGROUND:

The Lake Avenue Bridge Rehabilitation over the Owasco Outlet (the Project) extends along Lake Avenue from the Owasco Street intersection to the Osborne Street intersection over the Owasco Outlet. The rehabilitation involves making repairs to the steel superstructure, painting the steel members, partial depth repairs to the concrete substructures, replacement of the bridge deck, sidewalks, and railings, and possible upgrades to utilities attached to the bridge.

The Project extends approximately 570 feet across Lake Avenue on the bridge over the Owasco River between the intersections of Owasco Street and Osborne Street. All proposed work associated with this Project will be completed within previously disturbed areas of the existing 135 to 200-foot transportation right-of-way (ROW) along Lake Avenue in between Owasco Street and Osborne Street. The ground disturbance will be a maximum of 10 feet below grade for the back wall reconstruction, 2 feet below grade for the sidewalk replacement and full pavement section reconstruction, and 1 foot below grade for the partial pavement reconstruction. Ground disturbance will be limited to the minimum area required to complete the Project activities.

The Project has been classified under the NY State Environmental Quality Review Act (SEQRA) as a Type II action, in accordance with 6 NYCRR Part 617.5, Subdivision (c) illustrated by the following:

(2) replacement, rehabilitation or reconstruction of a structure or facility, in kind, on the same site, including upgrading buildings to meet building, energy, or fire codes unless such action meets or exceeds any of the thresholds in Section 617.4 of this Part.

Additionally, the Project meets the criteria specified in 6 NYCRR Part 617.4. Given the Project meets the above criteria, it may be classified as Type II under SEQRA. Based on the classification of the Project as Type II, no further SEQRA compliance is required.

Background:

The City of Auburn has obtained through various means, mainly tax foreclosure, a unique mix of vacant residential buildings and lots. As staff reviewed this list, there was consensus that some of these properties could attract higher dollar values, as well as different purchasers, than through the typical auction process.

The City released a Request for Proposals (RFP) for the purpose of hiring a real estate firm experienced in residential real estate to provide marketing and brokerage services for properties owned by the City. On January 12, 2024, proposals were opened and subsequently scored by a review committee representing the City Manager, Corporation Counsel, Comptroller and Planning.

Proposals were received from the following firms:

- The Real Estate Agency
- Hunt Real Estate ERA
- Riordan Realty

All firms who responded were qualified and were scored based on the following criteria:

The compiled average scoring was as follows:

- The Real Estate Agency 91.25
- Hunt Real Estate ERA 82.5
- Riordan Realty 81.25

As outlined above, The Real Estate Agency received the top average score of 91.25, based on the scoring criteria. Please see attached proposal for further information.

Fiscal Implications:

The Real Estate Agency will provide real estate services for 7% of the cost of each property sold.

Fully Fund Medicaid Reimbursements in the NYS Budget

Background:

Medicaid funding plays a vital role in supporting our healthcare system, encompassing hospitals, nursing homes, and ambulance providers. Inadequate funding can strain the financial stability of healthcare providers, limit access to care, and compromise the quality of emergency medical services for vulnerable populations.

In the fall of 2022, the City of Auburn initiated the Auburn City Ambulance Department to ensure reliable ambulance responses for residents. We have learned in this process that Medicaid significantly influences the billing of ambulance services, especially for those dependent on Medicaid for healthcare coverage.

Medicaid guarantees eligible individuals access to emergency medical transportation. Insufficient Medicaid funding for ambulance services leads to reduced availability, particularly in rural or underserved areas. This results in prolonged wait times for emergency care, possibly endangering patient outcomes. The impact is evident statewide in New York, affecting ambulance providers and healthcare facilities in all regions.

Medicaid reimbursement rates set by New York State pose financial challenges for ambulance providers, especially smaller rural ones like the City of Auburn. The City depends on Medicaid reimbursements to cover equipment, personnel, and operational expenses. Reduced funding strains the financial sustainability of ambulance services, affecting emergency medical service availability.

Through the attached resolution, the City Council aims to convey concerns to the Governor and State legislature on behalf of frontline workers in community hospitals, nursing facilities, and the Auburn City Ambulance service.

Gun Involved Violence Elimination (GIVE)

In the spirit of cooperation and collaboration to reduce the occurrence of violent crime in the City of Auburn, the Cayuga County District Attorney's Office, the Auburn Police Department, the Cayuga County Sheriff's Office, the Cayuga County Probation Department, the New York State Police, the New York State Department of Corrections and Community Supervision and the Central New York Crime Analysis Center (CNYCAC) have entered into partnership regarding anti-crime efforts targeting violent crime.

Your recent involvement in violent incidents has come to the attention of the Auburn GIVE Unit (Gun Involved Violence Elimination), Auburn GIVE is a partnership comprised of law enforcement, social services, and the community, whose goal is to reduce violence in our community. The GIVE law enforcement partners include the Auburn Police Department. Cayuga County Sheriff's Office, New York State Police, Cayuga County District Attorney's Office, Cayuga County Probation Department, New York State Parole, and federal law enforcement agencies including the FBI, DEA, ATF, U.S. Marshals and U.S. Attorney's Office. Based on your prior history, the GIVE partnership is concerned that you are at high risk of becoming a victim or an offender victimizing someone else.

A recent review of your criminal history indicates that should you become involved in any criminal offense involving violence and/or weapons, the consequences will be severe. Based on your specific criminal history you face the following sentence in prison:

- B felony up to 25 years,
- · C felony up to 15 years,
- D felony up to 7 years.

These sentences will include an additional period of Post-Release Supervision (parole supervision) between 3 and 10 years.

You are currently an Auburn GIVE Unit priority at risk individual. Should you choose to continue to engage in violent behavior, you are at risk for prosecution to the fullest extent of

Should you choose to seek support and assistance, rather than continue to engage in criminal activity, the Auburn GIVE Unit will provide you with an opportunity for services to assist you in a positive manner. We strongly encourage you to take advantage of these opportunities and services by calling Probation Officer Darren Walawender (315) 253-1528, Heather - Nicks Ride 4 Friends or Cayuga Counseling (see attached cards), By simply making this call, you will receive personalized support.

It is our hope that you will follow the laws of New York State. However, you have been forewarned, XXX XXXX, that you have come onto our radar, and we are watching for any crimes that you may commit in the future with a new, particular interest. The people of our community -your community - want the violence to stop, and agree that there is no excuse for it. Violence will not be tolerated.


